<b>Abstract:</b>	This collection contains military records, personal correspondence, mementos, newspaper clippings, and photographs pertaining to Captain Lillian Shapiro, the first member of the Women's Army Auxiliary Corps from Haverhill, Massachusetts.

### Biographical Sketch

Lillian Shapiro was born in 21 July 1908 in Siberia, Russia, to Louis and Eva Shapiro. She moved with her parents to Haverhill, Massachusetts, in 1912 and graduated from Haverhill High School in 1926. After high school she worked as an office manager/bookkeeper at Pioneer Mounting and Finishing Company.

Shapiro enrolled in the Women's Army Auxiliary Corps. on 28 July 1942 and was released from active duty effective 26 January 1946. She enlisted as an officer, initially given the rank of 2nd Lieutenant with ultimate promotion to Captain. During this time her positions included Motor Transport Instructor, Company Commander, Detachment Commander, Battalion Commander, and Control Officer. After the war she moved to New York City and worked as an office manager at an advertising display company. She died on 23 April 1987.
