Abstract: This collection covers the story of Hannah Duston's captivity, the

memorials erected in response to her actions, and Duston

descendants.

Biographical Sketch

Hannah Duston was born in December 1657 to Michael and Hannah (Emerson) Duston in Haverhill, Massachusetts. She married Thomas Duston, Jr. in 1677. During King William's War on March 15, 1697, Haverhill was raided by the Abenaki people of Quebec. During the raid, Hannah Duston was in her house with her newborn daughter, Martha, and her nurse, Mary Neff. Thomas Duston, who was working nearby, was able to escape with their other eight children, but Hannah, Martha, and Mary Neff were taken as prisoners. During the journey to their imprisonment, Martha died. Hannah Duston would later recount to Cotton Mather that her captors murdered Martha. Hannah and Mary were taken to a location near Penacook, New Hampshire, where they were joined by Samuel Leonardson, a 14-year-old boy taken prisoner from Worcester, Massachusetts. The three of them managed to escape on April 30, 1697, when Hannah used a hatchet to kill some of the men, women, and children who held them as prisoners. Hannah scalped her victims to be taken as proof of her ordeal, then she, Mary, and Samuel returned to Haverhill.

Several accounts of Hannah Duston's captivity and actions were written in the following two centuries. Many are sensationalized and paint a heroic picture of Hannah Duston, but it must be noted that no official records or verified firsthand accounts of the event are available, nor are there accounts from the perspective of the Abenaki people.

Due to the sensationalized accounts, memorials were erected to commemorate Hannah Duston's story in the latter half of the 1800s. The first one was dedicated in 1874, on the island of Boscawen, New Hampshire. The second one was dedicated in 1879, in the Haverhill Common, which later became G.A.R. Park. Haverhill had previously tried to erect a statue of Hannah Duston in 1852, but due to budget restraints and disagreements over the location of the statue, the project did not come to fruition.

The Duston-Dustin Family Association formed in 1905, under the name Dustin Historical Genealogical Society of Haverhill. Since the creation of the organization, an annual meeting is held at Haverhill. **Hattie Angeline (Dustin) Kilgore** worked with the Duston-Dustin Association to publish *The Story of Hannah Duston* in 1940.
