<b>Abstract:</b>	This collection provides a general overview of the history and activities of Mitchell & Company, a department store in Haverhill, Massachusetts.

### Organizational History

Mitchell & Company was founded in 1872, by Frank J. Mitchell and his brother, Seth K. Mitchell. Five years later Mr. George W. Thayer joined the organization. Calico, cotton cloth, silks, and dry goods were the principal items sold in the first few years. This partnership continued until 1902 when it was dissolved and Mr. Nicholas C. Johnson became associated with Mr. Mitchell. The firm was incorporated in 1905, with Frank J. Mitchell as president and Nicholas C. Johnson as treasurer. Upon the death of Frank Mitchell in 1921, Nicholas Johnson became president and treasurer with Tom W. Mitchell as vice-president. In 1926 Nicholas C. Johnson and his three sons acquired the Mitchell interest in business.

In April 1945, Mitchell & Company purchased two buildings and two parcels of land partially occupied by the store immediately adjoining it. The property, at 90-98 Merrimack Street, was occupied on the ground floor by Whelan Drug Company, and Di Tommaso & Sons, jewelers, with offices and tenements on the second and third floors. The reason for the purchase was to allow for further expansion in future. In April 1959, the top two floors of the Mitchell and Johnson Building, 76 to 86 Merrimack Street, were torn down; the cost of repairing, heating, and taxes were a major factor in the decision.

In 1971, Mitchell & Company was doing well; there were 28 departments in the store and it employed 100 people. However, in late 1979, the company said that they were having trouble attracting women shoppers between the ages of 18 to 30. As a way to address the issue, they looked to consolidate departments and move some of the women's department from the

basement to street level. The department store continued to face challenges and, in 1985, the 113-year-old company closed, due partially to flagging sales and a shift in customer buying habits.

## Scope and Content Note

This collection provides a general overview of the history and activities of Mitchell & Company, a department store in Haverhill, Massachusetts. It has been arranged into four series. Series one contains an employee handbook and a scrapbook. Series two consists of photographs. Series three contains advertisements and series four contains objects, such as boxes, a clothes hanger, and pneumatic tubes used in the store.
