**Abstract:** This collection contains the papers of Pauline Jordan Rankin, Red

Cross nurse during World War I, Near East Relief Worker after the

war, and Prisoner of War in Japan during World War II.

# **Biographical Sketch**

Pauline Jordan was born in Maine on August 20, 1892, to Angie Washburn. When her mother died, she moved to Haverhill to live with her aunt, Nettie W. Small. She graduated from Haverhill High School in 1907 and Columbia University School of Nursing in 1915, then immediately joined the American Red Cross.

She was deployed to Europe during World War I, beginning with the French theater, where she studied at the Institute of Radium under Marie Curie. In 1916, Rankin was sent to Bucharest, Romania, where she was taken prisoner by the Germans. She escaped to the Russian border.

After the World War I, Pauline worked in Armenia for Near East Relief; she organized an industrial plant, and ran a hospital and orphanage in Alexandropol, which treated patients blinded by trachoma. She met Karl L. Rankin, an official of the United States Department of State, while working for Near East Relief and they married in 1925.

The Rankins were stationed in Manila, Philippines, when the Japanese invaded in December 1941. They were taken prisoner and forced to participate in the Bataan Death March. After three years of imprisonment, they released as part of the Gripsholm Exchange. President Truman appointed Karl Rankin as ambassador to China after World War II.

The Rankins retired to Maine, and Pauline died on November 12, 1976.
