Abstract:	Joseph Haynes was a farmer, dry-goods store owner, and lumber trader in Haverhill, Massachusetts, during the mid- to late 1700s. The materials in the collection document Haynes' life and that of his family members through estate and legal documents, financial records, plot plans, and a few maritime documents.

Biographical Sketch

Joseph Haynes was born on 5 February 1715 in Haverhill, Massachusetts, to Thomas Haynes (1680-1771) and Hannah Harriman (1677-1761). He was a farmer, owned a dry goods store, and sold lumber. He was chosen to hold many positions of public trust and was a delegate to the First Provincial Congress (1774-1780) in Salem representing Haverhill. He was a member of West Parish Congregational Church. In 1755, a number of congregants led by Joseph Haynes accused their pastor, Rev. Samuel Bachellor, of heresy and Bachellor was ultimately removed in 1761. Haynes was reported to have owned slaves, two of which were named Peter and Selah Jarsey (died 1834). He wrote and published several pamphlets.

In 1734, he married Elizabeth Clement (1717-1756) and they had 14 children. After his first wife's death, he married Mehitable Marsh (1738-1826) and they had 12 children: Mary (1757-1837); Jonathan (1759-1833); John (1761-1803); James (1763-1812); Robert (1766-1812); Tristram (1769-1848); Mehitable (1772-1852); Warren (1775-1859); Sarah (1777-1842); Moses Haynes (1780-1871); Anna (1783-1853); and Guy Carleton (1786-1877).

Haynes died in Haverhill on 26 December 1801.

Scope and Content Note

The Joseph Haynes family papers document the life and activities of Joseph Haynes (1715-1801), his children, and business associates. Because Joseph Haynes served as administrator for Captain Richard Ayer (1726-1781), this collection contains a small group of Ayer's papers. Of interest on the back of an Ayer estate document (Timothy Ladd's account), is a partial letter dated 1779 from the Committee of Safety for the town of Haverhill. Documents include estate and legal documents, financial records, some plot plans, and a few maritime documents.
